Selected Project Experience

Ag Pilots Project, 2006-2009: At the request of the Governor's Office and with the support of the Legislature, the Center developed the Ag Pilots Project to encourage innovative demonstration of on-the-ground activities that promote a vital agricultural economy as well as produce benefits for the environment. The Project's design was based on consultations with agricultural, environmental, tribal and community leaders. The dual goals of the Ag Pilots Project were to promote innovative ways to "enhance farm income" while at the same time "improve natural resource protection." The Project also sought to build bridges among the agriculture and environmental communities.

New Legislator Workshop, 2006: Workshop and orientation for newly elected Washington State legislators. Ten newly elected Members from the Washington House of Representatives attended a two-day long workshop on basic demographics, policy development and collaborative problem solving. The primary goal of the workshop was to give the new Members insight into what their new roles would entail and resources available. The workshop was developed in collaboration with experienced legislators, legislative staff and facilitation practitioners.

Northwest Straits Marine Conservation Initiative, 2004:

The Northwest Straits Marine Conservation Initiative is a unique local governance mechanism that employs a collaborative approach to preserve ecosystems while respecting existing economic and community uses of marine resources. The Center managed a federally-mandated independent evaluation of the Initiative. Convening a committee of scientific and other experts, the Center staffed the performance review. What the panel found was one of the most innovative applications of volunteer action anywhere in the country. The credibility and thoroughness of the evaluation led to a stronger mandate and increased federal support for the Initiative.
