Subject: LID Outreach Contract for SRRTTF-ACE, work is completed

Work has been accomplished according to the four tasks outlined by Specification No. 005-18. In summary:

- 1. A presentation was developed about LID for towns, cities, and community groups in the Spokane Basin. A PDF of the presentation is available.
- 2. Spokane Riverkeeper staff gave the presentation 5 times. 17 entities were contacted, but most were either not interested, or could not fit the presentation into the timeframe. A list of entities contacted is below.
- 3. A one-page handout on PCBs was developed and distributed to 22 home improvement stores. The *Business Stormwater & Waste Disposal Guide* was also distributed to almost all of the 22 stores. A PDF of the handout is attached.
- 4. This memo provides summary information about the work accomplished. Below you will find information about where the LID presentations were made, some summary data about the effectiveness of the presentation, and a list of all the home improvement stores where the one-page handout was distributed.

The presentation was given at the Kootenai Environmental Association's monthly happy hour, Spokane Central Lions Club, E Spokane Kiwanis Club, Liberty Lake Planning Commission, and South Hill Kiwanis Club. 28 surveys were completed. The survey consisted of 5 questions. Questions and results are as follows:
