PCB Flyer Update:

- Vikki mentioned that SRHD communications team is still working on the draft PCB flyer, hoping to have something available at the January meeting.
- We talked about making sure to have consistent messaging. Is there a way we could provide any content onto the fish advisory? It was mentioned that there is already a lot of information on the fish advisory and it would be too cluttered.
- We talked about having a visual flow on the flyer, maybe looking into a 2- or 3-fold brochure.
- Chelsea mentioned that the intern for the land's council hands out health advisory information at community events and we could look at including the PCB flyer for these events.

Spring Campaign:

- There was discussion about the pre-roll ad's and the length we would want to consider doing.
- If the main goal of the Spring campaign is to get people to the waste directory there was some discussion on if there was a way to update or revamp the waste directory and make it more user friendly? Can the E&O workgroup include this in one of our projects for the year and help support an update to the waste directory if the River Forum would like to look into this? Vikki will email Andy and Tonilee to ask if they would be interested in looking into revamping the Waste Directory webpage.

School Curriculum:

- Toni mentioned that they are looking into revamping the Drain Rangers program from Western Washington and include some things from Eastern Washington into it for a Fall 2020 teacher workshop. Toni will keep us updated.

SRRTTF PCB Webpage:

- Toni maintains the webpage and mentioned that there are ongoing costs with maintaining it.
 - If there is something people would like added to the webpage, if you could send those to Toni and she will make sure they get posted.
 - There was mention that as workgroups complete projects or have updates if they can email those to Vikki or Toni and we can post those to the webpage as well.
 - We mentioned that the header of the webpage still needs to be updated from previous comments that were discussed at the July 9th E&O meeting.
 - Vikki will email Kristin and see if she can get the header design file and email that to Toni Taylor.

- Chelsea mentioned that the Land's Council is seeking funding and submitting application for the EPA Columbia River Restoration grant.
