Projects that can be completed by June 2021:

- Joel mentioned that from the Funding workgroup there was a potential additional \$60,000 that would need to be used up by June 2021 and if there were any projects that the E&O workgroup would like to put forward to the full task force.
- Karl mentioned that the additional funds were a max of \$60,000 but between the \$30-40,000 range.
- The spring campaign was brought up as an option.

Andy- Spring Campaign:

- Andy mentioned that he would be looking at \$15-17,000 for the spring campaign. Same amount as we did for 2020.
- Looking at doing more 1-minute pieces and pre-roll videos
 - Andy mentioned about doing a pilot for the pre-roll for both Facebook and Instagram. The group decided to spend the remaining money from the 2020 campaign on an oil pre-roll video
- The new waste/recycle directory should go online in the next couple of weeks.
 - o There will be a soft launch in November with the live launch in December.
- We will recommend to the full task force meeting Dec 2, 2020, the Spring 2021 campaign proposal.
 - We will also recommend a pilot project on Instagram for the pre-roll videos
 - We can refine the details of the messaging to see if we need to change any messaging.

Andy-Paint Stewardship-Spring 2021

They will be having a big state roll out in the Spring of 2021.

- Andy mentioned that the spring campaign can tie into the paint stewardship roll out as well.
- It will be about paint care and where you can go to drop off unused paint.
